

Privacy Notice - Volunteers' Application Form

You may tick a box and sign the application form to acknowledge you have read this Privacy Statement but may be asked to return a signed copy of this form as part of the application process.

Thame Senior Friendship Centre is a registered charity (charity number 1039978). This data privacy notice will explain how we use any personal data we collect from you in the attached form. Any references to 'us' or 'we' hereafter in this privacy notice therefore relate to Thame Senior Friendship Centre.

Thame Senior Friendship Centre is the sole data controller of any personal data you provide us. We will not share your data with any third party without your explicit consent. Your data will not be transferred abroad.

We collect data via the 'Volunteer Application Form' for the following purposes:

- To enable us to contact you regarding voluntary work with Thame Senior Friendship Centre
- To enable us to ascertain your suitability to volunteer with Thame Senior Friendship Centre according to your locality to the Centre, and by carrying out a Disclosure and Barring Service check (DBS, formerly known as CRB).

Legal Basis for Processing your Personal Data

Under GDPR, a legal basis for data processing must be defined. In this case, Thame Senior Friendship Centre will rely upon consent as the legal basis for the processing of data for the purposes outlined above:

Article 6. 1. a: the data subject has given consent to the processing of his or her personal data for one or more specific purposes.

Thame Senior Friendship complies with the General Data Protection Regulation (GDPR) by keeping data up to date, by not collecting more data than is required for the purposes listed above, and by taking appropriate measures to ensure your data is stored securely and protected from loss, misuse and unauthorised disclosure. The data you provide via this form will be stored securely, either electronically or in a locked facility if supplied on paper. It will be stored for no longer than 5 years, after which time it will be securely destroyed. The collection and storage of your data is done in line with the Thame Senior Friendship Centre's GDPR Policy.

Your Rights

The GDPR provides the following rights for individuals:

- The right to be informed of the data we collect, and how we process and use your data
- The right of access you have the right to request a copy of the data Thame Senior Friendship Centre holds about you
- The right to rectification you have the right to request that we update any of your personal data which you believe to be inaccurate or incomplete
- The right to erasure you have the right to request that we delete your personal data, under certain conditions
- The right to restrict processing you have the right to object to our processing of your personal data, under certain conditions
- The right to data portability you have the right to request that we transfer the data we have collected to another organisation, or to you directly, under certain conditions.
- The right to object
- Rights in relation to automated decision making and profiling.
